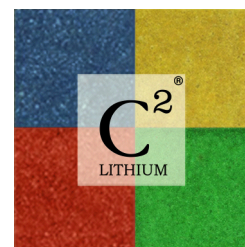

4. FIRST AID MEASURES

First aid measures

5. FIRE-FIGHTING MEASURES
