**4. FIRST AID MEASURES****First aid measures****General advice**

Immediate medical attention is required.

**Eye contact**

Immediate medical attention is required. Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Keep eye wide open while rinsing. Do not rub affected area.

**Skin Contact**

Immediate medical attention is required. Wash off immediately with plenty of water while removing contaminated clothing and shoes. Call a physician.

**Inhalation**

Remove to fresh air. Call a physician or poison control center immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.

<b>Ingestion</b>	Immediate medical attention is required. Do NOT induce vomiting. Rinse mouth. Drink plenty of water. Remove from exposure, lie down. Never give anything by mouth to an unconscious person. Call a physician or poison control center immediately.

<b>Symptoms</b>	Causes severe burns. Fatal if inhaled. May be harmful if swallowed.

<b>Note to physicians</b>	Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.

## 5. FIRE-FIGHTING MEASURES

### **Suitable Extinguishing Media**

### **Specific hazards arising from the chemical**
